Health Care Services

What is Health Care Services? Health Care Services provides personal and professional help for you, during your health care experience.

Why Health Care Services? Medical Associates Health Plans is committed to the delivery of quality health care to you, our member. Working with you, health care providers, and employers, we have developed a system of being accountable for the delivery of accessible quality health care.

How is “managed care” delivered? We would like you to choose a main doctor for your primary care. You will also have access to other providers for specialty care. The Chief Medical Officer of Medical Associates Health Plans and a staff of nurses will work with you and your doctor to make sure that you get the care you need. Health Care Services Department is available Monday through Friday 8 am to 5 pm. After hours calls are answered by Patient Services.

How do you benefit from Health Care Services?

Utilization Management: Utilization Management is a monitoring system that assures services are delivered to Medical Associates Health Plan members at an appropriate level of care and in a timely, effective, and cost efficient manner. This is accomplished by continually assessing and improving the quality of care and resource allocations within Medical Associates Health Plans.

Continuity of Care: To make sure that you receive the care you need, your doctor may plan for care with another doctor. Case Managers in the Health Care Services Department can arrange for referral appointments for specialty care and coordinate the sharing of information between your doctor and the specialist.

Concurrent Benefits Determination: Case Managers in the Health Care Services Department can help you determine your coverage before you are hospitalized or when you need a referral appointment. This process ensures that services will be given in the most appropriate setting based on your needs.

Concurrent Review: Case Managers in the Health Care Services Department review our members' care when they are admitted to a hospital; this is accomplished on site or by telephone. Concurrent review is done for the purpose of reviewing the care received, establishing length of stay needs, determining the appropriateness of continued hospital stay and discharge planning so that when patients go home they have the services they need such as Home Health ready for them. Case Managers use nationally developed criteria when reviewing our members care.

Prior Authorization: Case Managers in the Health Care Services Department review all requests for services such as same day surgery, inpatient admissions, out-of-plan referrals and out-of-area care to determine appropriate care for members and coverage.

Focus on Preventive Health: Health Care Services promotes wellness and preventive care. We invest in your good health by covering services that help prevent illness and keep you well. This helps to reduce costs that occur because of an illness.

Case Management: Case Managers in the Health Care Services Department help guide you through the health care system before, during, and after your care. They act as a mediator for all members of the system: you, providers of care, employers and health care facilities. Following are ways in which the nurses help to carry out the "managed care" approach:

- Educating you on the use of your Health Plan
- Determining hospital and referral coverage
- Assisting you with doctor referrals
- Exploring care choices other than hospitalization
- Promoting wellness and preventive health care
- Approval for out-of-town medical care
- Supporting continuity of care
- Communicating information between health care providers
- Aiding in home health care services

Care Outside the Medical Associates Health Plans Service Region

Urgent Care Out-of-Area

What happens in an emergency? You can receive emergency care from a non-Health Plan doctor or provider without preauthorized approval. However, you or a family member should call our Health Care Services Department within 48-hours. Your coverage is limited to medical care and supplies needed during the emergency, before you can be transferred to a Health Plan doctor. **Emergency Care** means health care that you require in life threatening, disabling, serious illness or injury situations. This includes severe pain that could worsen suddenly and if not treated could result in loss of life or permanent damage. You do not need Prior Authorization for emergency care. (Please refer to your Evidence of Coverage for a thorough definition of “Emergency Services.”)

Medical Associates Health Plans (MAHP) only covers *emergency* care out of the service region. However, if a member is out of the service area on business, vacation or attending school and feels that he/she needs medical attention for a condition that is non-emergent, (see above Section for definition of “emergency”), the member may call his/her MAHP physician to discuss the medical problem. Please advise the Health Care Services Department of any potential care required outside the service area as soon as possible so the case can be monitored and benefit questions can be answered, especially in the case of hospital admissions.

All requests for out of area “non-emergent” care received by the Health Care Services Department are reviewed and approved or denied according to established guidelines. If it is not reasonable for the member to return to the service area, non-emergent out-of-area care, i.e., sore throat, ear infection, etc., may be authorized by a Health Care Services Case Manager. The Case Manager will grant approval for the needed scope of care according to established guidelines that are approved by the Chief Medical Officer. The member must call for prior approval and will be advised of billing procedures and authorization for additional out-of-area services.

Routine Care Out-of-Area

If a MAHP member initiates *routine* care, i.e., routine physicals, lab tests, therapy, etc., outside the service area without prior approval of the Chief Medical Officer, the patient will be held responsible for the charges incurred.

For Medicare members: authorization will be granted for medical services when requested by treating in plan physician/provider for members with ongoing medical needs who will be out of service area. Examples include pro times for members on blood thinners, dialysis out of service area, physical therapy, etc. An authorization for these services will be entered into the information system. If you are planning on being out-of-area and have ongoing medical needs, please contact your treating physician to make arrangements for continuous care prior to leaving the service area.

- Always carry your Member I.D. Card when you travel. Show your card to the doctor or hospital where you get medical care.
- Call our toll-free number (see Contact Page 4). It is on the back of your Member I.D. Card. A relative or friend can call for you if you are unable to make the call.
- If you are admitted to a hospital, call our Health Care Services Department within 48 hours. They will talk with the hospital and doctor to verify coverage.
- If you have a minor medical problem, call our Health Care Services Department for pre-approval.

- If you have a bill or receipt for pre-approved care, send it to our Claims Department. You will be reimbursed based on your contract.
- Health Care Services Department (see Contact Page 4).

How to Submit a Claim

In general, when you receive your health care from a participating provider, you will only be required to pay any deductible or co-payment specified in your insurance policy. If you receive authorized services from a non-participating provider or outside of the local service area, you may be required to pay for services at the time they are received or you may get a bill at a later date. Medical Associates Health Plans will reimburse you for medically necessary services covered under your policy. You must submit your claim to Medical Associates Health Plans within 90-days after the date of such service. Failure to submit a claim within 90-days will not cancel or reduce any claim if it was not reasonably possible to give proof within the time required, provided such claim is submitted as soon as reasonably possible, and in no event later than one year from the date of service.

If the physician or health care provider will not directly bill Medical Associates Health Plans, ask for a completed medical claim form such as the “HCFA 1500 Universal Form” that includes all patient and provider information needed to process your claim.

If the physician does not use the universal claim form, the following information is needed for us to process your bill. Ask the provider for a receipt that includes:

1. Name of your health insurance policy as listed on your membership card
2. Name of the policy holder as listed on your membership card
3. Name of the patient receiving medical services
4. Name, address, and telephone number of the physician or health care provider
5. Diagnosis
6. Type of health care services rendered, with diagnosis and/or procedure codes
7. Date service was given
8. Charges for services given

If you or the health care provider have any questions, you can call the Member Services Department (see Contact Page 4) will be able to assist you in submitting your claim.

Medical Associates Health Plans requires that all physicians and providers demonstrate and foster a commitment to treating patients in a manner that respects their rights. The Health Plan also believes that all patients have responsibilities for cooperating with those providing health care services. Open communication between practitioners and patients is encouraged. All practitioners participating with Medical Associates Health Plans are able to freely communicate with patients regarding the treatment options available to them. These options include medical care, risks, benefits, consequences

of treatment or non-treatment, as well as the opportunity of the patient to refuse treatment and to express preferences about future treatment decisions.

Your Rights as a Member

You have the Right:

- to be treated with dignity and respect and to have your right to privacy recognized.
- to receive information about the Health Plan, its services, its practitioners and providers and members' rights and responsibilities.
- to obtain from your doctor, complete, current information concerning your diagnosis, treatment and prognosis in terms that you can reasonably be expected to understand. When it is not medically advisable to give you such information, the information will be made available to an appropriate person on your behalf. You have the right to know, by name, the doctor responsible for your care.
- to participate in decision making regarding your health care.
- to receive from your doctor information necessary to give informed consent prior to the start of any procedure and/or treatment. Except in emergencies, such information for informed consent should include, but not necessarily be limited to, the specific procedure and/or treatment, the medically significant risks involved, and the probable duration on incapacitation and treatment. Where medically significant alternatives for care or treatment exist, or when you request information concerning medical alternative, you have the right to such information. You have the right to know the name and qualifications of the person responsible for the procedures and/or treatment.
- to refuse treatment to the extent permitted by law and to be informed of the medical consequences of your actions, including the termination of physician/patient relationship.
- to every consideration of privacy concerning your own medical care program. Case discussion, consultation, examination, and treatment are confidential and will be conducted discreetly. Those not directly involved in your care must have your permission to be present.
- to voice complaints or appeals about the managed care organization or care provided.
- to expect that all claims, communications and records pertaining to your care will be treated as confidential in accordance with Federal and State laws.
- to expect, within its capacity, that the Participating Providers will make reasonable response to the request of the patient for services. The caregiver will provide evaluation, service, and/or referral as indicated by the urgency of your case. When medically permissible, you may be transferred to another facility only after you have received complete information and explanation concerning the need for and alternatives to such a transfer. The institution to which you will be transferred must first have accepted you for transfer.
- to be advised if the provider proposes to engage in or perform human experimentation involving your care or treatment. You have the right to refuse or to participate in such research projects.
- to expect reasonable continuity of care. You have the right to know in advance what appointment times and doctors are available and where. You have the right to expect there will be a mechanism whereby you are informed by your doctor of your continuing health requirements following examination and/or treatment.
- to examine and receive an explanation of any denied services under Medical Associates Health Plans and to request consideration of denied claims according to the terms of your contract.
- to a candid discussion of appropriate or medically necessary treatment options for your condition, regardless of cost or benefit coverage.

- to access Emergency Services without prior authorization when you, as a prudent layperson, acted reasonably, believing that an Emergency Medical Condition existed. Payment would not be withheld in cases where you sought Emergency Services.
- to receive urgently needed services when traveling outside the Plan's service area. You must contact the Health Care Services Department for pre-authorization. Payment would not be withheld in cases where you received pre-authorization.
- to make recommendations regarding the organization's member's rights and responsibilities policies.

Your Responsibilities as a Member

You are expected:

- to follow the rules and regulations of Medical Associates Health Plans
- to be committed to health maintenance through health enhancing behavior and preventative health services. Illness can often be prevented by a healthy lifestyle and preventative care. You are expected to take personal responsibility when you are able to avoid the development of a disease.
- to the best of your ability, to provide accurate and complete details about your past illnesses and present medical illness or condition. You must tell your doctor when and for what you have been hospitalized in the past, as well as the medicines or other medications you are now taking or have taken in the past.
- to inform your doctor and/or nurse if there is an unexpected change in your condition or if problems arise in your treatment.
- to tell your doctor and/or nurse if you do not understand your treatment or if you do not understand what you are expected to do. You are responsible if you refuse treatment or do not follow instructions and guidelines.
- to follow advice, instructions and guidelines of the doctors, nurses, and other personnel concerning your care. You are responsible if you refuse treatment or do not follow instructions.
- to keep your appointments and you must tell your doctor, nurse, or receptionist if you cannot keep your appointment.
- that you are a member of the Medicare Plan, you are responsible for paying your premiums when they are due. If you are unable to pay your premiums, it is your responsibility to notify our Finance Department.
- to be courteous to the participating providers, staff and other patients.
- for reviewing your Evidence of Coverage and understanding the coverage and exclusions under that agreement. If you have any questions on the terms or conditions of that coverage you are responsible for contacting Medical Associates Health Plans to obtain information and answers to your questions.
- to understand your health problems and participate in developing mutually agreed upon treatment goals to the degree possible.

Member Confidentiality

Medical Associates Health Plans respects the privacy of all of its members. Employees and providers of care will show respect for patient confidentiality by not accessing a member's medical record unless the medical record is necessary for the provision of medical services or the administration of the Health Plan. Review and release of member/patient medical information will not occur without proper authorization from the member or his/her representative or as otherwise allowed by law.

Medical information obtained during the process of utilization review, case management, quality improvement and measurement of quality will be kept confidential in accordance with federal and state laws. This information will be used solely for the purposes of utilization review, quality assurance, discharge planning and case management. Medical information will only be shared with the Health Plan's Chief Medical Officer, Health Care Services staff, Pharmacy Coordinator, Quality Improvement staff, appropriate Claims Processing staff who have authority to receive such information, and external review organizations.

Marketing staff and other Health Plans staff shall not divulge personally identifiable member information to the Employer without specific release from the member.

Member information released to vendors shall be maintained in confidence between Medical Associates Health Plans and the vendor. Contracts with these vendors will comply with HIPAA regulations.

Members may view their Health Plan file at any time. Members who wish to view their file are asked to call ahead and make an appointment to visit the office at which time a consent form will be signed. A Health Plan staff member will then locate the file and remain present during the review.

Obtaining Primary & Specialty Care

You have direct access to any Participating In-Network primary care practitioner (Internal Medicine, Family Practice, General Practice, OB/GYN) and most Participating In-Network specialists. We encourage you to establish yourself with a Participating In-Network primary care practitioner for continuity of care. If you need to see a specialist, you have direct access to most of them by calling the phone number listed in this directory. If a specialist requires that you to be referred from a primary care practitioner, you will be informed of this when you call the specialist. If you have questions in regard to accessing any of our Participating In-Network providers, please call our Member Services Department (see Contact Page 4). If you have specific questions about a medical condition and aren't certain who you should see, please call our Health Care Services Department (see Contact Page 4).

Mental Health and Substance Abuse

All MAHP members needing mental health or chemical dependency services are able to call directly to the Psychiatry Department to make an appointment, unless they are using a non-participating provider. Then the member will need to call the Health Care Services Department (see Contact Page 4).

Disease Management

Disease Management is initiated with select health plan members who have chronic illnesses that require continuing medical care and education to prevent acute complications and to reduce the risk of long term complications. The goals of disease management are to reduce and/or eliminate hospital admissions, to promote wellness and members' active participation in their health care, to provide ongoing education, and to achieve a more personalized approach to case management. The Disease Management Nurse will also send you educational material about your disease to assist in your education process and keep you well informed.

Our Quality Improvement Department currently has two active disease management programs in place to assist members with Diabetes and Cardiac Care including Hypertension (Blood Pressure). Please contact the Quality Improvement Department (see Contact Page 4) for more information.

Language Interpretation

Medical Associates Health Plans has the ability to provide language interpretation for members who do not speak the English language. For more information, please call the Member Services (see Contact Page 4). For members who have difficulty hearing, call Relay Iowa at 1-800-735-2943 and the operator will assist you in making your phone call.

Diabetic Coverage

Medicare Part B covers some diabetic supplies, including blood sugar (glucose) testing monitors, blood sugar (glucose) test strips, lancet devices, lancets and therapeutic shoes. There may be limits on how much or how often you can get these supplies. Please verify benefits with the Member Services Department (see Contact Page 4).
